**Re: Ultra Gas Warranty Program – Time Sensitive Information**

Dear Dealer,

When you sell your customers a Weil-McLain Ultra Gas boiler you are providing them, at no additional charge, peace of mind in knowing that their new boiler has parts and labor coverage for 5 full years from the date of installation against any defective electronic or mechanical parts. There are no hidden deductibles, and no limit on the number of claims that may be made during the coverage period.

To initiate coverage, **your customers must mail in the warranty registration card located in the literature envelope shipped with each Ultra Gas boiler within 30 days of installation.** The free 5-year coverage is not in effect until your customer receives a confirmation and a contract number from CornerStone United, the warranty program administrator. All late registrations will be subject to a 60-day waiting period before coverage begins.

For those homeowners who have not registered a boiler installed over 30 days ago, **Weil-McLain is offering a grace period until Friday, March 6, 2009 to submit claims on unregistered boilers.** After March 6, 2009 if a claim is submitted on an unregistered boiler, the boiler will be registered and the 60-day waiting period will begin. The homeowner will be responsible for the initial claim and any subsequent claims during the waiting period.
